

Statement of support for Robert F. Kennedy Jr. as Secretary of Health and Human Services (HHS)

America spoke and will not be silenced. We want President Trump and Robert F. Kennedy Jr. to Make America Healthy Again. We trust and applaud their vision.

As concerned American citizens invested in transparent and innovative public health leadership, we support the decision to appoint Robert F. Kennedy Jr. as Secretary of Health and Human Services (HHS), recognizing his commitment to challenging industry influence in public health policy and unleashing public discourse on complex health issues.

As stakeholders in public health who prioritize open dialogue and individual medical autonomy, we view the criticism of RFK Jr.'s appointment as an attempt to suppress legitimate questions about the chronic disease epidemic. - "Return our health agencies to their rich tradition of gold-standard, evidence-based science."
- Investigate declining fertility by looking at the effects of the pesticide glyphosate, chemicals in plastics, heavy metals, and nutrition.
- "I will provide Americans with transparency and access to all the data so they can make informed choices for themselves and their families," he said.
- End censorship. We need urgent protection of free speech, which he points out is a right, not a privilege.



- He thinks Americans can handle "dangerous thoughts or contrary ideas that don't fit the MSM [mainstream media] narrative." We can have "thought-provoking conversations" and "decide for ourselves."
- Remove seed oils from fast food. The switch from tallow to using seed oils coincided with the start of the obesity epidemic.
- Investigate why the CDC recommends "unsafe and ineffective" COVID shots for babies who are at "near zero risk" for the illness.
- Ban harmful food additives that have already been banned in other countries but not in the U.S.
- "We will get chemicals out of the water, air, food, and soil," he said.
- End the chronic disease epidemic to Make America Healthy Again.

In summary, RFK Jr. is only a threat to bloated and corrupt government institutions, the legacy media that's withholding information, and major industries attempting to control American policy, such as pharmaceutical, offshore wind, processed food products, pesticides, chemical and plastics manufacturers.
